



## 2024-2025 (V1) Verification Worksheet - Independent

Your 2024-2025 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. The law says that before rewarding Federal Student Aid, we may ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information the financial aid administrator at your school will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. **You must complete and sign this worksheet, attach any required documents, and submit the form to the financial aid administrator at your school.** Your school may ask for additional information. If you have questions about verification, contact your financial aid office as soon as possible so your financial aid will not be delayed.

**SECTION C1: STUDENT 2023 IRS INCOME TAX FILER**

Instructions: **Complete this section if the student filed a 2021 IRS Income Tax Return.** *The best way to verify income is by using the IRS Data Retrieval Tool (IRS DRT) that is part of FAFSA on the Web at FAFSA.gov.* In most cases, no further documentation is needed to verify 2023 income information that was transferred into the student's FAFSA using the IRS DRT if that information was not changed.

**How will you provide your 2023 Income Tax Return Information? Check the box that applies:**

- IRS DRT** -The student **has used** the IRS DRT in the *FAFSA on the Web* to transfer 2023 IRS income tax information into the student's FAFSA.
- Will use the IRS DRT**- The student **has not yet used** the IRS DRT in *FAFSA on the Web*, but will use the tool to transfer 2023 IRS income tax return information into the student's FAFSA once the 2023 IRS income tax return has been filed.
- Will provide a copy of your 2023 IRS Tax Transcript or Return**- The student is **unable or chooses not to use** the IRS DRT in *FAFSA on the Web*, and instead will provide the school a **2023 IRS Tax Return Transcript(s) or a signed copy of the 2023 income tax return and applicable schedules.**

A **2021 IRS Tax Return Transcript** may be obtained through:

- **Get Transcript by Mail** – Go to [www.irs.gov](http://www.irs.gov), click "Get Your Tax Record." Click "Get Transcript by Mail." Make sure to request the "Return Transcript" and **NOT** the "Account Transcript." The transcript is generally received within 10 business days from the IRS's receipt of the online request.
- **Get Transcript Online** – Go to [www.irs.gov](http://www.irs.gov), click "Get Your Tax Record." Click "Get Transcript Online." Make sure to request the "Return Transcript" and **NOT** the "Account Transcript." To use the Get Transcript Online tool, the user must have (1) access to a valid email address, (2) a text-enabled mobile phone (pay-as-you-go plans cannot be used) in the user's name, and (3) specific financial account numbers (such as a credit card number or an account number for a home mortgage or auto loan). The transcript displays online upon successful completion of the IRS's two-step authentication.
- **Automated Telephone Request** – 1-800-908-9946. Transcript is generally received within 10 business days from the IRS's receipt of the telephone request.
- **Paper Request Form** – IRS Form 4506T-EZ or IRS Form 4506-T. The transcript is generally received within 10 business days from the IRS's receipt of the paper request form.

**SECTION C2: STUDENT NON-TAX FILER**

Instructions: **Complete this section if the student DID NOT file a 2023 Tax Return** and **are not required** to file a 2023 income tax return with the IRS.

**Check the box that applies:**

- UNEMPLOYED**- The student and spouse **were not employed** and had **no income** earned from work in 2023. **EMPLOYED**-
- The student and spouse **was employed in 2023** and has listed below the names of all employers. The amount earned from each employer in 2023, and whether an IRS W-2 form is provided. **{Provide copies of all 2023 IRS W-2 forms issued to the student by their employers}**

If more space is needed, provide a separate page with the student's name and ID number at the top.
